



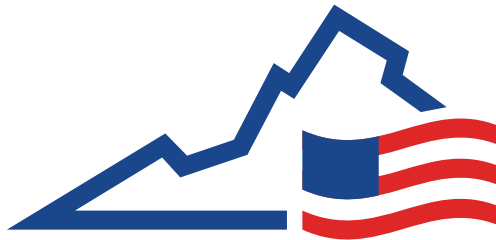

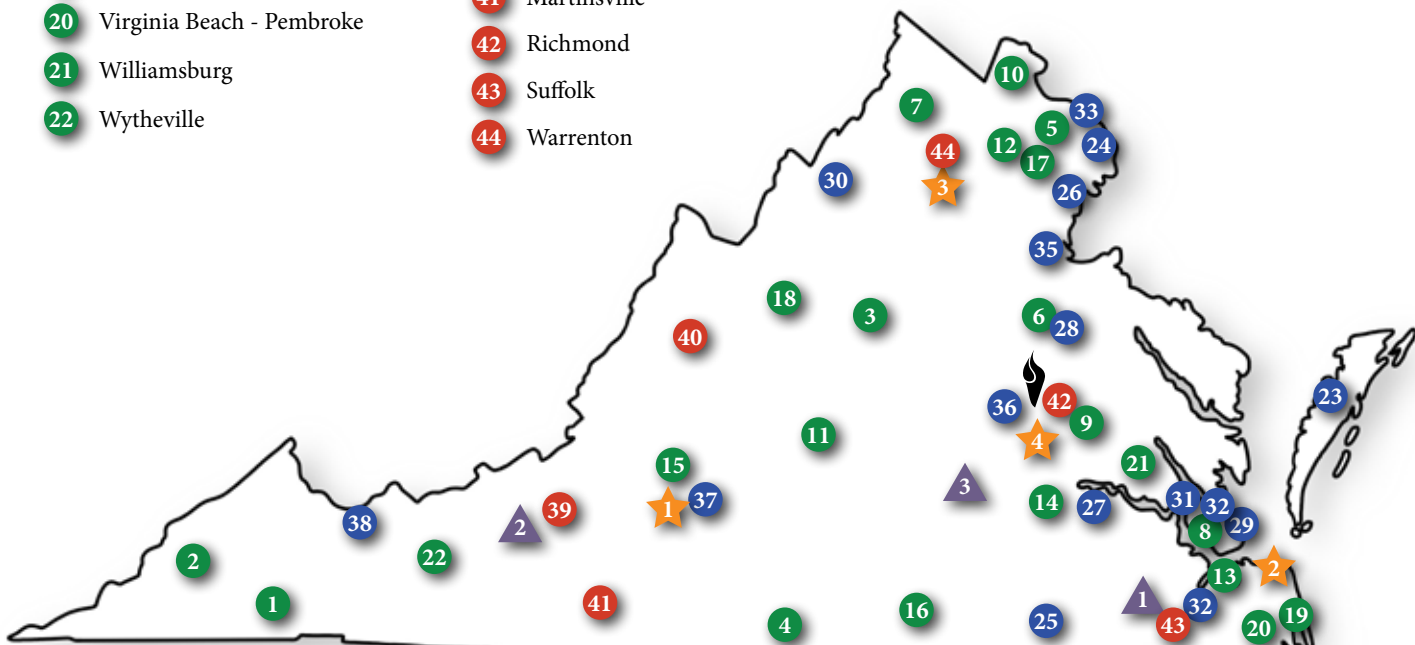

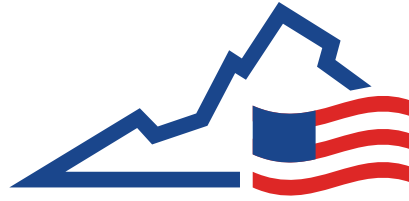

The Virginia Department of Veterans Services is fully engaged in this venture with a firm confidence that hiring Veterans is not just the right thing to do - understanding who Veterans are and hiring them will increase organizational productivity and efficiency.

# YOUR RIGHTS UNDER USERRA THE UNIFORMED SERVICES EMPLOYMENT AND REEMPLOYMENT RIGHTS ACT

**USERRA protects the job rights of individuals who voluntarily or involuntarily leave employment positions to undertake military service or certain types of service in the National Disaster Medical System. USERRA also prohibits employers from discriminating against past and present members of the uniformed services, and applicants to the uniformed services.**

## REEMPLOYMENT RIGHTS

You have the right to be reemployed in your civilian job if you leave that job to perform service in the uniformed service and:

- ☆ you ensure that your employer receives advance written or verbal notice of your service;
- ☆ you have five years or less of cumulative service in the uniformed services while with that particular employer;
- ☆ you return to work or apply for reemployment in a timely manner after conclusion of service; and
- ☆ you have not been separated from service with a disqualifying discharge or under other than honorable conditions.

If you are eligible to be reemployed, you must be restored to the job and benefits you would have attained if you had not been absent due to military service or, in some cases, a comparable job.

## RIGHT TO BE FREE FROM DISCRIMINATION AND RETALIATION

If you:

- ☆ are a past or present member of the uniformed service;
- ☆ have applied for membership in the uniformed service; or
- ☆ are obligated to serve in the uniformed service;

then an employer may not deny you:

- ☆ initial employment;
- ☆ reemployment;
- ☆ retention in employment;
- ☆ promotion; or
- ☆ any benefit of employment

because of this status.

In addition, an employer may not retaliate against anyone assisting in the enforcement of USERRA rights, including testifying or making a statement in connection with a proceeding under USERRA, even if that person has no service connection.

## HEALTH INSURANCE PROTECTION

- ☆ If you leave your job to perform military service, you have the right to elect to continue your existing employer-based health plan coverage for you and your dependents for up to 24 months while in the military.
- ☆ Even if you don't elect to continue coverage during your military service, you have the right to be reinstated in your employer's health plan when you are reemployed, generally without any waiting periods or exclusions (e.g., pre-existing condition exclusions) except for service-connected illnesses or injuries.

## ENFORCEMENT

- ☆ The U.S. Department of Labor, Veterans Employment and Training Service (VETS) is authorized to investigate and resolve complaints of USERRA violations.
- ☆ For assistance in filing a complaint, or for any other information on USERRA, contact VETS at **1-866-4-USA-DOL** or visit its website at <http://www.dol.gov/vets>. An interactive online USERRA Advisor can be viewed at <http://www.dol.gov/elaws/userra.htm>.
- ☆ If you file a complaint with VETS and VETS is unable to resolve it, you may request that your case be referred to the Department of Justice or the Office of Special Counsel, as applicable, for representation.
- ☆ You may also bypass the VETS process and bring a civil action against an employer for violations of USERRA.

The rights listed here may vary depending on the circumstances. Federal law requires employers to notify employees of their rights under USERRA, and employers may meet this requirement by displaying the text of this notice where they customarily place notices for employees.

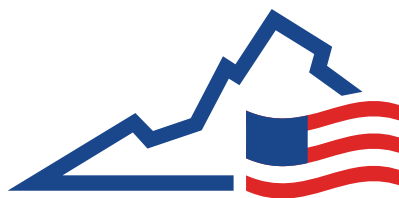

## Military Medics and Corpsmen Program

### VETERANS AND MILITARY SPOUSES: YOUR PATH IS CLEAR TO A CIVILIAN HEALTHCARE CAREER

How can the Military Medics and Corpsmen (MMAC) Program help you? Easy. Give us your employment and education goals. We'll put you on the path to reach them. Looking to continue in patient care? Perhaps a non-clinical career that matches your military training and experience? Maybe a leadership role? Are you a Military Spouse seeking a position in Virginia's healthcare system? Whatever path you choose . . . we'll clear it for you.

#### Path One: MMAC Qualified

Are you a veteran or transitioning Medic, Corpsman, or Medical Technician with less than 12 months since you practiced hands-on clinical care? You may be MMAC Qualified. Only in Virginia you can continue to practice your clinical skills without the required civilian healthcare credentials – while in school to get those credentials. Keep skills sharp and credentialing on track with MMAC.

#### Path Two: No Veteran Left Behind

From HR to the ER or from PT to IT or engineering, healthcare needs people now with clinical and non-clinical military training and experience. Ever thought of a non-clinical role in HR, logistics or HVAC? We can help. Next to a patient, behind a desk, or on a ladder, we'll help find your place in healthcare.

#### Path Three: Healthcare Leadership

Hospitals are like military installations. They need experienced leaders to keep things running efficiently and effectively. Are you that leader? From leading a practice or program, to managing safety, supply chain, infrastructure or information technology – if you are management material we'll help find your fit.

#### Path Four: Military Spouses

As a Military Spouse looking to start or continue a career in Virginia's healthcare system, you've come to the right place. We are advocates, an employment resource, and a source of credentialing information. MMAC sets you up for success and potential employment at MMAC Partner Healthcare Systems and Virginia Values Veterans Certified Healthcare Employers statewide. Spouses serve too. Let MMAC serve you.

#### What We Do At MMAC:

The MMAC team recruits, reviews and refers candidates to healthcare employers statewide. The hiring decisions and scope of practice are up to the employers. While we don't provide licensure and certification or direct financial assistance – we do clear the path for your next mission: being part of Virginia's civilian healthcare team. Whatever your role – we've got your route.

## FINDING EMPLOYMENT

As a Transitioning Service Member, Veteran, Spouse, or Military Family Member, you will find help locating your next job at an American Job Center (AJC). In Virginia the AJC is called the “Virginia Career Works” (VCW) Center. The VCW is comprised of nine agencies that provide free help to job seekers for a variety of career and employment-related needs and you will receive “Priority of Service”.

Furthermore, AJCs have experienced career counselors on staff that work with job seekers to identify their interests, assess their skills and abilities and advise them on in-demand jobs and potential training opportunities. Many AJCs also offer recruiting events, workshops on resume writing, interviewing skills, and job search activities.

Comprehensive AJCs offer free services and are open to the general public. Services vary by location but can include:

- Resource rooms with phones, free internet and resume writing tools
- Employment plan development
- Job training services
- Career Exploration
- Job search assistance
- Resume building
- Career counseling
- Practice interviewing
- Skills testing
- Labor market and employer information
- Employment workshops
- Supportive services (which can include information about SNAP, financial assistance, Medicaid, training services, child care, emergency funds, and other benefits)
- Hiring events and business service information
- Accessibility and special accommodations for people with disabilities
- Referrals to community resources and other agencies, and more
- Access to your state’s job bank or CareerOneStop’s national Job Finder
- Unemployment insurance information

The Virginia Employment Commission (VEC) is a part of the VCW and serves all Transitioning Service Members, Veterans, Spouses, and Military Family Members. The VEC also oversees the Jobs for Veterans State Grant which hires dedicated staff to provide individualized career and training-related services to veterans and eligible persons with significant barriers to employment, and help employers fill their workforce needs with job-seeking veterans.

You are strongly encouraged to register as a Job Seeker with the Virginia Workforce Connection for access to all the services available and so you can find a job and Employers can FIND YOU! You will find Job Search, Career Information, Training Opportunities, Skill requirements, Labor Market Information including Wage data, Industry and Occupational trends. ## HIRING PREFERENCE IN STATE GOVERNMENT

The Commonwealth of Virginia and Virginia localities give preference to honorably discharged veterans of the armed forces of the United States in its employment hiring policies and practices, provided that such veteran meets all of the knowledge, skills and eligibility requirements for the available position. Additional consideration is also given to veterans who have a service connected disability rating fixed by the U.S. Department of Veterans Affairs. The Commonwealth of Virginia extends its veterans hiring preference to active members of the Virginia National Guard as well. The surviving spouse and dependents of service members killed in action are also entitled to the hiring preference.

Furthermore, veterans who are disabled, who served on active duty in the Armed Forces during certain specified time periods or in military campaigns are entitled to preference over others in hiring for virtually all federal government jobs.

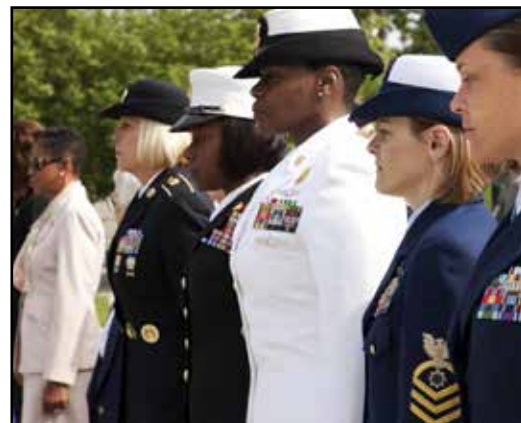

Credits2Careers ([www.credits2careers.org](http://www.credits2careers.org)) is a free academic and career portal, designed specifically for prospective military and veteran students. The portal presents multiple academic pathways for veterans based on their military experience and allows them to see potential prior credit awards before applying to a Virginia Community College System (VCCS) school. The portal also provides an opportunity to explore career paths and resources related to the certifications that will be important for a particular career.



### Virginia Military Survivors and Dependents Education Program

The Virginia Military Survivors and Dependents Education Programs (VMSDEP) is a Commonwealth of Virginia program which provides education benefits to spouses and children of military service members killed, missing in action, taken prisoner, or who became totally and permanently disabled or at least 90 percent permanently disabled as a result of military service. Military service includes service in the United States Armed Forces, United States Armed Forces Reserves, or the Virginia National Guard.

## CONNECTING VETERANS TO EARNED BENEFITS

The Virginia Department of Veterans Services advocates for Virginia veterans and connects them to benefits and services they have earned. Information on current federal, state and local veterans' programs, entitlements and referral services are available in Virginia through a network of 34 benefit service offices ([www.dvs.virginia.gov/benefits](http://www.dvs.virginia.gov/benefits)). All services are provided free of charge. For additional information visit [www.dvs.virginia.gov/benefits](http://www.dvs.virginia.gov/benefits) or one of the offices on the following page.

Eligibility for most federal and state benefits is based on discharge from active military service under other than dishonorable conditions. Active service means full-time service as a member of the Army, Navy, Air Force, Marine Corps, Coast Guard, the United States Space Force, or as a commissioned officer of the public health service, the Environmental Services Administration, or the National Oceanic and Atmospheric Administration. Current and former members of the Selected Reserve and National Guard may be eligible for certain benefits, such as home loan guaranties and education, if they meet time-in-service and other criteria.

## CEMETERY BENEFITS

The Virginia Department of Veterans Services' three veterans' cemeteries provide final resting places for our soldiers, sailors, airmen, Marines, and Coast Guardsmen in places of honor, dignity, respect, and remembrance. Spouses may be interred in the same gravesite as the veteran at no cost; eligible dependent children may be interred in the same gravesite as the veteran for no fee. The grave space, columbarium niche, headstone/marker and vault or crypt are provided free-of-charge. This benefit also includes the use a facility for the committal service, military funeral honors, and perpetual care of the gravesite. These National Shrine-standard cemeteries are located in Amelia, Suffolk and Dublin. Each cemetery can accommodate in-ground burial of casketed remains, in-ground inurnment of cremated remains, and above-ground inurnment of cremated remains in a columbarium.

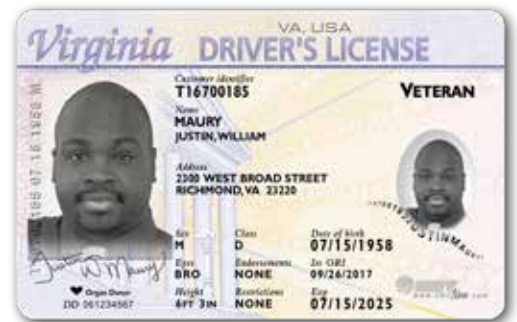

## DRIVER'S LICENSE - VETERAN INDICATOR

Veterans of the U.S. Armed Forces have the option of adding a veteran indicator to their driver's license or ID card. Having the word "veteran" appear on your driver's license or ID card is a convenient way to show your veteran status at retailers and restaurants that offer discounts to veterans.

### Eligibility Requirements

To be eligible for the veteran indicator, you must:

- Be a Virginia resident
- Apply for or currently hold an unexpired Virginia commercial driver's license, driver's license, learner's permit or DMV-issued ID card
- Have served either (1) in the active U. S. Armed Forces or (2) for more than 180 days in the Virginia National Guard or U. S. Reserves
- Have received an honorable discharge
- Present a photocopy of a veteran service proof document or combination of documents that provide branch of service, discharge date and discharge status (eg. DD 214, DD 256, WD AGO, or NGB 22). Alternatively, you may present your U.S. Military Retiree ID Card (DD Form 2) and a completed Virginia Veteran Military Service Certification application (DL 11).
- Consent for the information on your application and any subsequent address changes you make to be shared with DVS.

### Cost

There is no fee for the veteran indicator. However, you must pay the standard fee for an original or replacement credential that will display the veteran indicator.

### Applying for a Veteran Indicator

When applying for a veteran indicator, make sure that DMV has your current address on your record.

- You may apply for a veteran indicator online, by mail, by fax, or in person at a DMV customer service center.
- If you apply online, you must submit the required veteran status proof document(s) to DMV within 45 days of submitting your online application. These documents can be submitted to DMV online, by mail, fax or in person at a DMV customer service center.
- If you are applying by mail, fax or in person, you must complete a Virginia Veteran Military Service Certification (form DL-11) and provide a copy of your veteran service proof document(s).

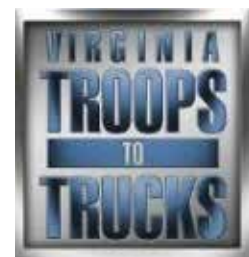


## TROOPS TO TRUCKS

Through the Troops to Trucks<sup>SM</sup> program, the Virginia Department of Motor Vehicles is making it easier for personnel trained by the military in the operation of heavy vehicles to obtain civilian commercial driver's licenses (CDL). ## DISABLED VETERAN AND SURVIVING SPOUSE REAL ESTATE TAX EXEMPTIONS

Veterans rated by the U.S. Department of Veterans Affairs (VA) as having a 100%, permanent and total, service-connected disability or who have a service-connected individual unemployable disability rating are exempt from paying real estate taxes on their primary residence. The exemption is based on the veteran's disability rating rather than the level of compensation. The exemption includes property held jointly by a husband and wife, and applies to the residence and up to one acre of land.

The surviving spouse of an eligible veteran who was receiving the tax exemption may continue to receive the real estate tax exemption. The spouse will lose the exemption if he or she remarries or does not occupy the property as his or her primary residence.

### Exemption Eligibility for the Surviving Spouse of a member of the U.S. armed forces who was killed in action

The surviving spouse of any member of the armed forces of the United States who was killed in action, as determined by the U.S. Department of Defense, and who occupies the real property as his principal place of residence, are exempt from paying real estate taxes. For purposes of this exemption, the determination of "killed in action" includes a determination by the U.S. Department of Defense of "died of wounds received in action."

## SERVICE-DISABLED VETERAN-OWNED SMALL-BUSINESS (SDVOSB) DESIGNATION

As part of the Virginia **Small, Women-owned, and Minority Owned Business (SWaM) certification program**, qualifying service-disabled veterans who are small business owners may obtain a **Service Disabled Veteran-Owned Small Business (SDVOSB)** designation in the Virginia SWaM vendor database. This is not a separate SWaM certification, but rather a designation of those small businesses that are owned by Service Disabled Veterans. SDVOSB certification is provided by the Virginia Department of Small Business and Supplier Diversity in partnership with the Virginia Department of Veterans Services.

## EXTENDED STATE TAX EXEMPTIONS FOR MILITARY RETIREES

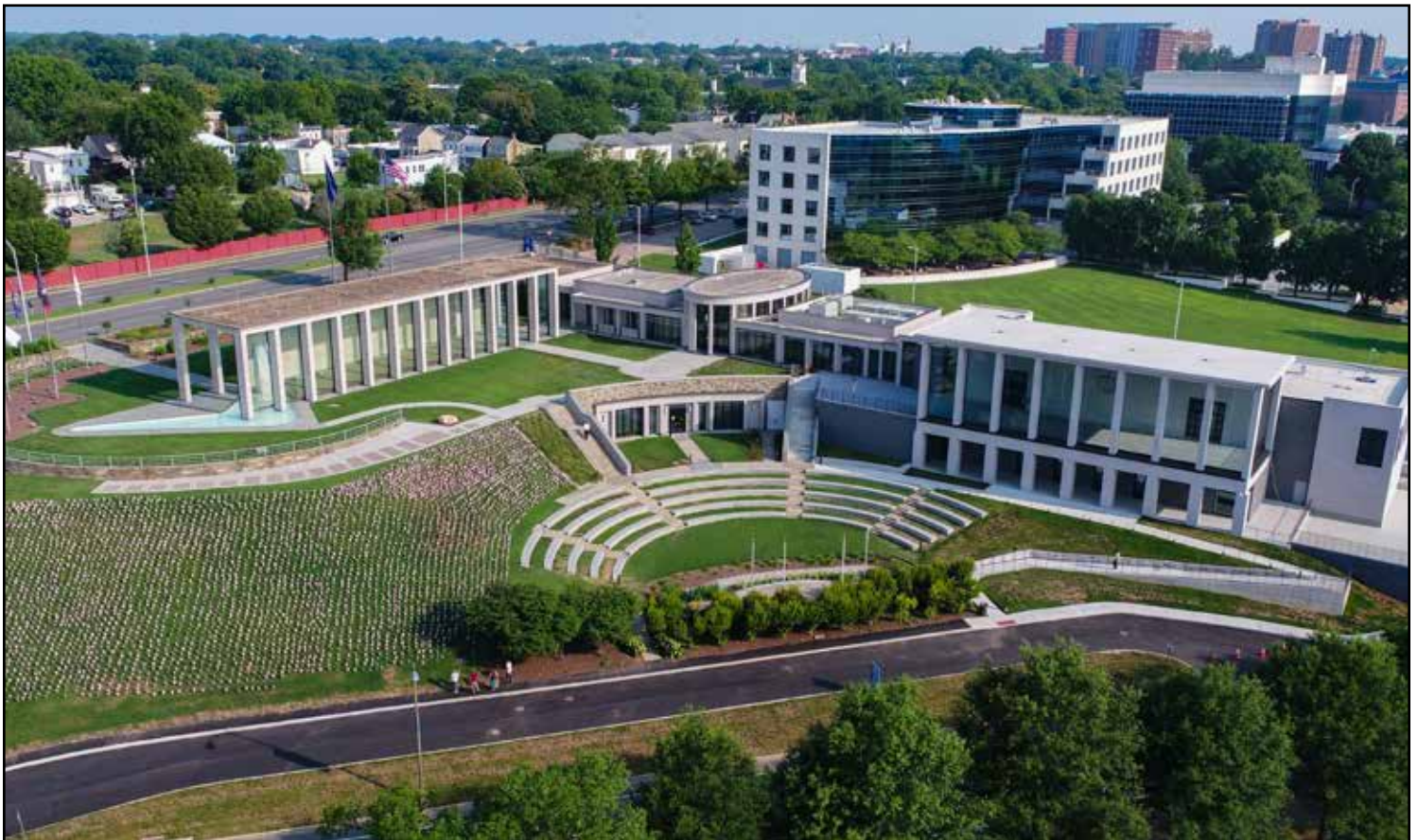

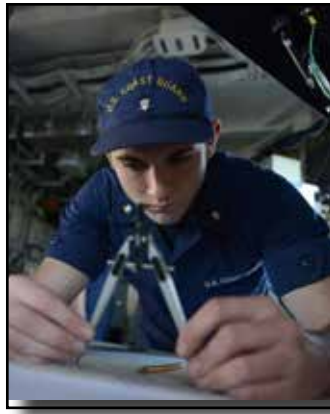
